

ORDER

Five Justices considered the case. Justices Denette Mouser, Houston Shirley, Amos McNac and George Almerigi concur. Justice Leah Harjo Ware recused and Justice Jon Chaudhuri was absent.

The Supreme Court reviewed the record de novo and finds no evidence that the Citizenship Board acted arbitrarily and capriciously. The Citizenship Board's final decision will be upheld. The District Court's Order remanding the case back to the Citizenship Board is hereby reversed. The District Court is hereby ordered to dismiss the case.
